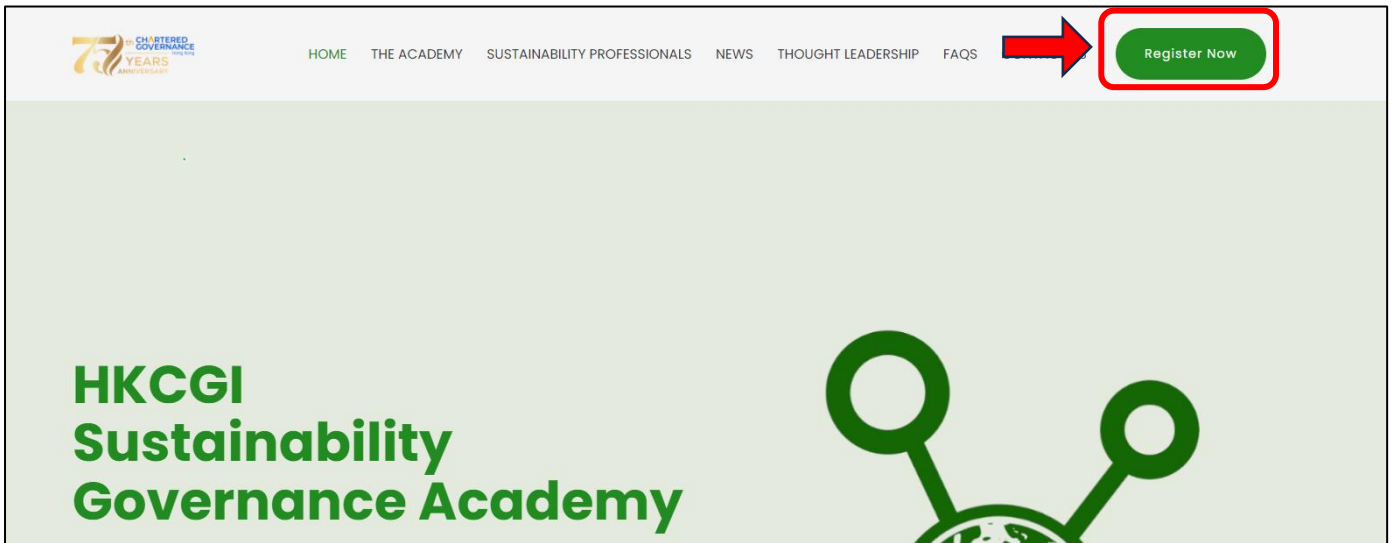


The Hong Kong Chartered Governance Institute Guidelines on Registration of Sustainability Governance Academy

HKCGI Sustainability Governance Academy (the “Academy”) is open to all individuals who are current Certification Holders of the ESG Reporting Certification Course. They can register as **HKCGI Sustainability Professionals** free of charge.

Step 1 – Go to the Academy’s website (<https://minisite.hkcgi.org.hk/academy/>) and click “Register Now” at the top right corner. You will be directed to the login page.



Step 2 – All Certification Holders of the ESG Reporting Certification Course should have an Institute’s user account. Please enter your registered email address, password and a captcha code. Press “Login” to access to your user account.
